Al Qaeda: Crime Should Be Praised, Not Punished

Abstract:

In this paper, we talk about yet another modality of violation of the human laws, which is part of the Al Qaeda system for non-compliance. Their members sometimes get arrested and, from those that get arrested, some might end up in jail but that doesn't last long: soon Al Qaeda comes to put them out with the collaboration of compliance authorities. That happens in every location where Al Qaeda has already been and that seems to be the entire world. We expose 3 serial killers who got freed by Al Qaeda at an early stage of their sentences and try to explain all that is involved.

I. Introduction

There is no prison for Al Qaeda members. They get out through new usurpations offered by the group and another person is left in their place to complete the needed time. The entire penitentiary system is corrupt: if it is not the cops keeping a watch over the marginal's cell, it is the managers. Al Qaeda always finds their way in and out.

That basically means that compliance is just like a 'fairy tale' during the entire term of existence of Al Qaeda: it serves the purpose of lightening the hearts of those who hear but, in practice, nothing is achieved by the end of it or all we are left with is dreams or illusion.

We will study three famous cases of psychopaths, three American males and one Venezuelan male: Jeffrey Dahmer, Larry Hall, Carlos Jackal and Ted Bundy. For each case, we perform a facial study that serves us as a proof of usurpation.

Development

We were told by a few members of Al Qaeda that Al Qaeda moves people out of jail and mental hospitals either after offering them their first usurpation package or after verifying that the arrested is already one of their members. Only Leinha told us about her direct involvement with that, so 'Lea Ricci Pinheiro', the multiples cluster that figures as 'my' 'sister' in the Brazilian usurpation I myself was passive part of, involving the families Ricci and Pinheiro and those connected to them via marriage or association (so co-workers, managers, people who usually serve them and whoever else that can identify the usurped as the original person instead of believing it is them).


We infer that Al Qaeda then uses elements from its mass of abducted people (they abduct a certain amount of people from at least Brazil, Australia, USA and England on a periodic basis) when producing replacements for those who they criminally put out of jail: 80,000 people per year from Brazil [1], more than 170,000 people per year from Britain [2], more than 600,000 people per year in the USA [3] and around 30,000 people per year from Australia [4].

We theorize that Al Qaeda keeps the abducted people somewhere in the world, bugs, brainwashes them with them being guilty of whatever crime it is and having been put in jail after due compliance processes plus inserts the narrative of the summons in their head in a way of making them own it (Leinha talks about that to me: that they can only go with whatever the summons state) before they are put in jail in place of those they are rescuing from it. Leinha tells me that she has a taste for serial killers and really likes when they do women (what matches the narrative of 'Nelson': that they aim at having only males in the end, all blacks, and half changed into women, so transgenders. Leinha is a transgender herself)..

If people are escaping mental hospitals through them, then they do the same: just that they will then brainwash the victim with them being mentally ill, having been put in the hospital and so on, probably with basis on the medical reports available in the records of the hospital.

Jeffrey Dahmer: Killed 17 men and boys [5]. He acted with extreme perversion and psychopathy. He would first dig up the coffins of his victims, then take them out and have sex with them. Later, he would flirt with men in gay places, take them home, offer them a drink with drugs in it, get them unconscious, murder them, and then commit various atrocities with their corpses. These included perforating holes in their skulls,

extracting penises, cooking and eating their flesh, drinking their blood, making holes in their torsos to use for sex, sleeping with the corpses, and dismembering them [5].



Different noses, skin color and chins. This looks really odd, like the original Jeffrey Dahmer had his life usurped pretty early according to these Wikipedia pictures (1978 (the one in the middle) is the earliest photo there and therefore he might have been himself until such a date, but not after that, so that we notice here that the guy who killed those men is probably being passed by Al Qaeda from one ID to another and he is then staining all the existences of those people who he 'becomes' and I still would assume all those people were always top Christians, since Al Qaeda would like him to raise as little suspicion as possible)



Here we notice 3 other 'versions' of this man: they are all different from the previous 3. Please pick by the nose and chin.


2 more versions of this man and they are also different from all the previous ones: nose and chin should do. We then presented at least 8 versions of the same ID, which is supposed to correspond to the ID of a very serious criminal, a serial killer: there are probably other men who figured as Jeffrey Dahmer both outside and inside of jail. Yet, this means that there were at least 5 swaps during the prescribed confinement term, so that at least 5 times Al Qaeda would have visited the Columbia Correctional Institution (Co-pilot's information), maximum security share of it [10], since 'Jeffrey' was a serial killer, and would have had no difficulties with taking him out of jail and putting another male in his place.

Al Qaeda gets this through its mass of usurpers, so people who, in principle, would have chosen to become part of Al Qaeda through accepting a new human existence in exchange for being bugged in the head, brainwashed and becoming therefore its slave. We theorize that most or all people in this situation would have been bugged and brainwashed by Al Qaeda before they were approached by them, so that their supposed will of doing such a thing may as well be the result of having their entire body, specially brain, 'handled' by the group in the most skilled way as possible. What that means is that the manager of this maximum security facility would be an Al Qaeda replacement of the original manager of the place, who Al Qaeda would have killed.

The motto of Al Qaeda is the satanic motto, so to inflict injury, suffering pain and loss to human kind. Things being such, Leinha would be very happy knowing that the serial killer hiding behind this stolen ID is, since the first swap, and until the end of his life, practicing his atrocities somewhere else in the world under a new stolen ID.

Larry Hall: He would have killed 35 women and girls [5]. He raped, tortured and murdered victims after abducting them according to Wikipedia [11].

The original Larry Hall was probably one of our relatives, since our names are Hall and Dunnam, as for Al Qaeda's information, and we do put strong belief in that being true. Larry Hall would have been usurped by 1972, since that is when Al Qaeda was doing the other members of our family, our mother having been their initial and main target, apparently because of her being an actress and having a movie screened in India in a public square soon before that date. I still saw something online, when Al Qaeda let more pass, about Elsie Hall being indeed an actress in a movie, which seemed to have exactly the scene Al Qaeda inserted in my head when 'Braganca' was telling me about how they felt watching it there, what would have led to their attack over us/our family. One of the women would have said, 'that one looks like us', which means that they wanted to usurp her existence, I now understand. According to 'Braganca', the men would have wished for being with her in her intimacy instead. What I imagine was my cousin was then usurped at the age of 10 yo. That obviously means that he himself never committed these atrocities and that was one more Al Qaeda thing. I believe our family was 100% Christian, so that we were a main target. The scene of the movie, where my mother would be the main actress, shows her with very well behaved clothes, of old style, covering her entire body, perhaps at most showing the cleavage, cannot be sure if even that was there, like I don't remember the full image, only some parts. That means that 'Braganca' was probably lying and using that rhetoric with me because he knows I connect a lot to love, like perhaps all American native white people did, and therefore I would see in that a plausible reason. He probably said something to the extent of making the other, who I believe was then 'Osama', feel as if she were a Christian instead, so that they were just pointing at her as ideal victim and the woman then manifested her will of usurping mum, in my best guess.



Please notice the differences: nose, chin and skin color are probably the most remarkable. We haven't by any means exhausted possibilities: this is just a superficial study to prove that there was at least 3 Al Qaeda swaps of the man claiming to possess the ID Larry Hall, and at least 2 of those would have happened while the man was in a medium-security prison (FCI Butner Medium II, according to Co-pilot (that Larry was there) and [14] (that that is a medium-security prison).

Leinha told me that the swaps are necessary because people who are under custody (I assume psychologists and psychiatrists but maybe even detectives) get re-interrogated with a certain frequency by staff and sometimes they ask questions that were not in the summons, so that Al Qaeda has to basically improvise, when they then brainwash another slave with the new narrative, including answer to the new questions asked, and swap once more.

Leinha had initially said that the reason as to why they swap them in jail is that they have multiples and those then share the jail time with the other who got caught. I did witness people at the Baschir's (Australia) swapping with their multiple while I myself was there (due to the Al Qaeda attacks, psychiatry). We now think she lied about that: they get swapped for slaves who have been bugged and brainwashed to become 'them', yet there is at least one group who watches things through me and think that is the right rhetoric, like, if they got to know what they actually do, perhaps they wouldn't be part, I now reckon.

I think the youngest version of this ID, as for the pictures above, is not my 'cousin' (just reckon Larry Hall was such, nobody told me that), since the man in the picture seems to be older than 10yo but my 'cousin' would have gotten usurped at most then.

The reason for the frequent swaps of the Al Qaeda who go to jail may also be that the brainwashed starts realizing they didn't really commit those crimes after a certain time in jail, like what else is one going to do there that be not self-reflection and they must be accompanied by psychologists or psychiatrists and those would eventually ask them to describe the scene of the crime but they wouldn't have that in their heads, so that they may end up with my observations and conclusions and therefore infer that they have been brainwashed or, worse, the mental health professional may have an expertise in brainwashing and be able to detect it.

Another point is that the parents of Larry Hall are a gravedigger and a homemaker, according to Wikipedia [11], but I really really think my relatives would not have such professions: one, I think all women in my family worked, like my mother and most American women. They are the ones who said 'let's judge ourselves as people' in public [15] to protest against the objectification of women: they were then referring to beauty competitions, like they thought that, instead of having our society judging who, among us, was the most geometrically perfect woman, we should obviously worry about judging our levels of wisdom in our actions, thinking and decisions. I also think that the males in our family would have good and higher-thinking-levels professions, never a gravedigger, which is simply mechanical and intellectually repulsive work (like even doing such a thing, having a grave instead of being rational and either eating corpses or incinerating them or preserving them somehow if it is important to try to have the same body alive again or available for studies of some type). I now believe this is part of the defamation campaign from Al Qaeda.

Carlos Jackal: At least 25 homicides and more than 100 people injured [16]. I watched a YouTube once where the presenter said he is known as the CIA killer because he killed a few CIA agents.

Please observe that the noses and the chins are different: even if you think the one to the rightmost position is the same as the one to the leftmost position, try to concentrate on things such as the chin, since the one to the rightmost position has more of a curve on it while the one to the leftmost position has a straighter chin. Yet only one of them, between those two, has cheeks as well, like the other has stretched skin instead. If you make half-face comparisons using a computer, you will notice the extraordinary difference involved: the nose is probably going to hit you the most. As in the other two cases, there should be more usurpations that can be detected via simple analysis of the pictures found in the media, but we here just want to prove that they did escape jail almost as soon as they got in and it is very likely that innocent people who have been subjected to bugging and heavy brainwashing but were guilty of nothing were then left in their place.

According to Co-pilot, he is in custody at the Centre Penitentiaire de Fresnes in France, maximum security, so that here we see how Al Qaeda 'runs' the penitentiary system in place of the respective governments: once more, they went there and swapped him a few times.

Ted Bundy: He brutally raped and murdered more than 30 women according to Wikipedia [18]. They still say he probably committed way more crimes than those and these are just those he confessed [18].

Here pick by the nose and the chin, for instance. 4 different men in the pictures above and there are still others even on the Wikipedia page. Notice that the 'flare' of the man who appears in the leftmost picture above is actually that of a psychopath.

We call all serial killers psychopaths because that is the popular understanding regarding the definition of the term: we do understand that some criminal psychologists are now using other terms for a few of them, such as sociopath, yet we think that the paper is better understood in this way.

The last picture of 'Jeffrey Dahmer' we showed on the 2nd page here, rightmost one, according to 'Nelson', is that of a man whose head had been cut off, like they put the head back and then took the picture, so after his head had been cut off.

II. Conclusions

We here studied 4 cases of psychopathy (as defined in popular culture) of major impact: Jeffrey Dahmer, Larry Hall, Carlos Jackal and Ted Bundy. It is proven that the original person, whose name is illegally appropriated by the marginal, probably never committed a crime in their lives and the marginal has not only stolen their name and either killed or agreed to the murder of those, but he has also ruined their official biography (by devaluating even the profession of the original person's parents).

It is also proven that these marginals never paid the penalty imposed by their societies for the atrocities they have committed: they left jail at an early stage of their term and someone else took their place there, someone who is extremely likely to have been bugged and brainwashed by Al Qaeda to believe they committed their crimes.

A simple facial study reveals the usurpations, so that, for the problem of illegal annihilation of compliance decisions or illegal nullification of penalties received, the simplest solution would be keeping track of the image of the marginal while he is in prison and having a universal database with the United Nations, together with a universal computer system that compares facial images and alerts compliance on matches.

Innocent people, who have been bugged and brainwashed by Al Qaeda, probably after being abducted, so that they would figure as marginals in place of those who actually committed crime, should be led to the realization of having received brainwashing by psychologists, psychiatrists and/or investigators: simple questions of the type what color of dress was she wearing, what material was the room where you killed her made of, did she move her arms to stop you and so on should lead to both parties realizing there is something wrong, if nothing else.

Compliance officers from the penitentiary system would have to be involved in the operations of Al Qaeda that develop in that direction, of putting guilty and charged people out and forcing the innocent in, and the reason would be that they themselves made use of an Al Qaeda usurpation package, so that they also replaced original people (those whose name in use correspond to the birth identity) and therefore either agreed with those being murdered or murdered them themselves. The way to stop that is imposing a Facial Evolution Study to the candidate to compliance officer: that they upload pictures of themselves from when they were a baby, when they were teenagers and a current one, to the least, so that the same system used to detect usurpation of existence of prisoners is used to check on them being originals or usurpers. If they claim not to have such pictures, they should be immediately disqualified.
