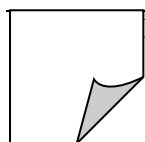

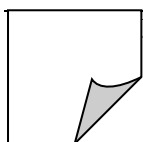

in the globalized world where the economic platforms determine ecosystems and poverty relates to environmental degradation (Martin, R., 1993).

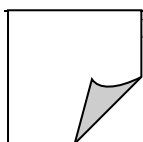

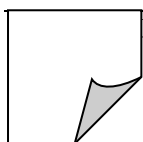
III. Steering The Future: Sustainable Development, The Implication Of The Rio Summit, And The Approach To Cosmopolitanism Ethics

IV. Recognizing The Relationship Of Human Progress, Ethics Of Cosmopolitanism, And Sustainable Development

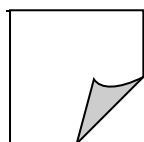

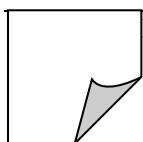
V. Guiding The Connection: Reconnoitering The Junctures Of Neo-Liberalism, Cosmopolitanism, And Sustainable Progress

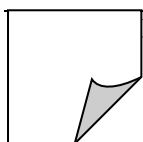
VI. Linking Global Conferences And Sustainable Development: A Cosmopolitan Viewpoint

In addressing pandemics or specific diseases there are the global health summits which emphasize the cosmopolitan initiative of health as an international public good. As their global health crises, the requirement



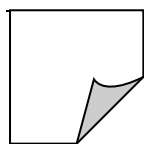

VII. Conclusion

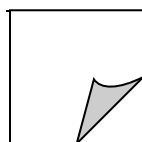
The ethics of sustainable development, global governance, collaboration, and the conferences characterize connected structural basics which are essential for shaping a developmental roadmap. By



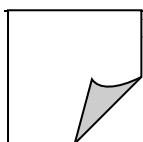
